Entries opened at noon on Friday 1 August, and again from 8:00 on the morning. The 20 dollar entry bought a way back: those runners floated down the Mendenhall River and were then bussed from the takeout at Brotherhood Bridge to Auke Bay School, with a clothesmobile carrying warm clothes to the river so nobody had to float in what they had run in. Everyone else went back from the finish by Gray Line motor coach. Prizes went to the first three men, the first three women, every 25th finisher and the craziest costume, and every entrant went into a drawing for a return flight for two to San Francisco from Alaska Airlines, a weekend for two to Skagway on the M.V. Having read this waiver and knowing these facts and inconsideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release the Juneau Trail and Road Runners, the United States Forest Service, the state of Alaska, the City and Borough of Juneau, and the Road Runners Club of America, all event sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver. In addition, I acknowledge the contagious nature of communicable diseases and voluntarily assume the risk that I may be exposed to or infected by communicable diseases by participating in this event. I acknowledge that such exposure or infection may result in personal injury, illness, permanent disability, and/or death.
