Course Description:

Location: Mendenhall Glacier Distances: 10 kilometers and 1 mile Rick Thibodeau won the 10K in 34:00 from Alan Graves in 35:55 and Steven Schmitz in 36:00. Jerry Boyd won the mile in 5:54, one second ahead of Joe Koch. 54 ran the 10K and 51 the mile. The mile was plainly a family race - the last three finishers took over 25 minutes - and it drew almost as many runners as the 10K. NOTE ON THE PLACINGS. The Empire prints 56 places in the 10K for 54 runners. Art Peterson appears at both 29 and 30 with the same 45:58, a line repeated across a column break, and there is no 48 - the list runs 47 straight to 49. The names and times are recorded as printed; the place numbers are not, and this site orders results by time in any case. The table gives no divisions and no genders, so none are recorded. The start time of 10:00 AM is a default rather than a reported figure.
